## **Description of Terms**

**Annual** – One payment by cash, check, or credit card for the entire school year's tuition on or before August 8<sup>th</sup>. A discount of \$200 will be given for all families (K-8) who use this option on or before August 8<sup>th</sup>.

**Semester** – Two payments by cash, check, or credit card for one-half the school year's tuition. The first payment is due on or before August 8<sup>th</sup>, the second payment is due on or before January 8<sup>th</sup>.

**Monthly** – Ten monthly payments by Electronic Funds Transfer. The payments will be taken on the eighth day of every month, beginning in August and ending in May. The monthly tuition amount can be electronically transferred from any savings, checking, or credit card account.

**Please Note:** While arrangements may be made to lower the tuition rate with grants and other forms of aid, no special payment schedules will be offered.

**\*\*** Active parishioners of neighboring parishes that do not have a parish school must secure a guarantee that the established subsidized amount is paid by their parish. By Diocesan policy, such parishes are expected to subsidize their active parishioners. A form, provided by St. Michael's, securing the subsidy from the neighboring parish, must be signed by the Pastor of that parish and returned at time of registration. Subsidizing parishes will be billed. If the status of a parishioner of a neighboring parish changes during the school year, the family is responsible for the undiscounted rate.
